There's talk of a sort of more physical violence and sadly. We know it happens, the research that I always remember showed that trans people were 12 times more likely to be on the receiving end or threat of violence or threats of it. I don't believe there's been a huge amount of change there. And now it's sort of and this, some, this article gives an example of the violence that happens in America, which I wouldn't come back.

Back to, you know, halfway through the show in another way.

Talks about at this point. Six hundred anti-trans bills in forty three US states. I didn't realize it was 43, mno new. Obviously there's division in America but to some extent between the coasts and the middle as they say but certainly a lot going on but in Australia the trans Justice project ninety four and a half percent of participants had been of trans people.

Surveyed said they've been exposed to online anti-trans hatred in the previous year. So this is difficult stuff and Austin fabric Jenkins who does great work. And I'm not sure when this article was originally written, all those who say it was published in international in September. So it might be a few years old or maybe Rel not Ultra recent but I'm Austin says that

Trans groups are more Brave than they have been before. That's true. Although, I'm just wondering whether as I've said a few times in the last few months, has the bubble burst. And, you know, it's the old binary stuff that he sort of makes life. So difficult for Trans and gender diverse people, and non-binary people. And although, of course, it's not gender variation of sex characteristics into characteristics intersex, people do experience the same thing, whether it's debates about Healthcare.

Boats education issues to do with housing and law. So there's all the issues that come up about medical treatment and getting a job. And this article quotes the late Dale crane, who was an absolute Pioneer for Trans particularly when trans men had less visibility. He was a teen in Melbourne's and killed her in the 70s Street kids and sort of, he lost a lot of friends because of that and I remember talking to one of the few I'm trans women whose

Survive this and killed a street scene and saying how difficult was back then and so Dale's, then partner, Andrew says, trans lives still don't matter. No, Miss Jen being misgendered, inappropriate questions disrespected, and people avoid the health system and this can be for a sort of General sort of Health situations that are not true.

Specific, but also the trans-pacific stuff, although things we have, it's always have to remember Victoria is, you know, sort of better than most places in the world and, well, up there in Australia or that the act and Tasmania are doing good things and other states and territories following the sort of, we do have to be to be aware of that. There's also expense that comes in with trans Health Care as well. So,

Certainly, you know, sort of lots to sort of to think about there, just to, even in the opening summary of this article and yeah, that we need to consider as part of trans history and then there's issues of employment. And I have to say that I've had some issues in the Healthcare System health issues recently which is meant going beyond my usual.

It's and whilst it's been really pretty good respect on Trans in itself year, there was no misgendering or anything, I still don't think there's quite enough understanding of the issues and what perhaps trans people experience that older trans people may have sort of deeply buried trauma that comes up. And you know there have been a couple of issues where I was treated, you know, sort of inappropriate.

Italy, but not necessarily just discriminatory, was it discriminatory, maybe it might be indirect discrimination or unconscious bias, so there's still, of course, there can always be that. And of course acknowledging, you know that there's race and colonialist issues in there and of course all sorts of colonial Powers have sort of

Delicate relegated. Sorry the level of gender diversity in original inhabitants societies the Aboriginal and Torres. Strait Islander sister girls and brother boys, the Navajo to Spirits the mush Olga of Kenya and Tanzania for phony of Samoa just to name a few. So gender and sexual fluidity. Now sort of florist across alongside women's Freedom before private property in.

Class divisions, evolved according to this article and societies will once again latarian where you had cooperation and that sort of technology and sort of has to some extent and industrialization has changed that. So yeah, there has been a change over time so certainly sexism is a part of it and now sir

So many times, trans people sort of end up sort of being kicked further down, rather than someone person who from outside the queer communities. Once said, to me, why are we all standing together? We imagine if we all, if we all did, you know, maybe we'd get at least somewhere.

I'm to a better more back to book to a better more equal place, but trans people will sort of fight on and, you know, sort of, we go back 18 months after the horrific events outside Pass State parliament in Victoria and then two weeks later that what the biggest queer rally, I can remember 5,000 people on trans day of visibility, and now we need in that sense, if transphobia and sexism are about it.

Enforcing patriarchal power in binary. He's certainly, we need to stand together. And that any exclusion of trans people in feminist debates, and quote, gender. Equality debates is simply not on, so great article. This one, and we just need to keep pushing on as best as we can. Mainstays of Australian anti-discrimination law. So it sort of all, we all know, politicians can break promises or not, keep them or whatever. So let's look at the records of the presidential and vice presidential candidates, not a lot from Trump, but this article quotes that Trump enacted to policies restricting, queer rights. Mating free speech and religious liberty federal law. Must respect, conscious based objections to comply with the First Amendment. That would save a lot of trouble and I think that this is one of the things that needs to happen in these debates about in Australia, is that there must be transparency for schools goods and service providers. If they want to discriminate and I don't believe they really have that right, particularly religious service providers in Regional and rural areas but they have to say it. And so we know where we stand and that would prevent things and prevent a lot of litigation and

And stress and all the rest of it. Now, the other thing, of course, Donald Trump did was Banning trans individuals from serving in the US, Armed Forces. He then, revoked the directive. But changed it to a new policy. So existing transfer military were allowed to stay but new Trans recruits couldn't enlist. Now not your sort of what that, you know, sort of what happens if someone in lists. And then now they realize they need to be trans. Do they have to

I'm very, very silly. But I remember saying a good ironic cartoon where America was under some sort of missile attack and Trump's sort of standing there and someone says well we don't know how to counter attack because we stacked the trans person and you how to do it. State governorships level, he's introduced or sponsored five bills, opposing trans rights, restricting, gender gender, affirming care and imposing criminal sanctions on doctors who perform surgeries, where's freedoms there and exposing Physicians to civil liability for prescribing gender, affirming hormones, goodness, me and also expanding healthcare workers ability to

Conscience based objections is Do no harm as they always say that seems to have gone down the tubes. And so that's also tried to pass legislation that would stop the Department of State, from issuing passports, with an unspecified X gender designation, which is in breach of the International Federation of Aviation organizations guidelines that policy was launched in 2021, it was easier to get an ex passport in Australia.

From 2011, and it's can be somewhat helpful for some for Trans and non-binary people possibly intersex. People Congress hasn't voted on any of these proposals. However, the Senate didn't get to vote on any of these bills in the end. So, 2021, Biden reversed, the Trump trans restrictions and the respect for Marriage Act which came in at a national level. Tim Waltz has

Supported granting Federal benefits to. Well, it says here same-sex couples. He's promoted inclusion, band conversion therapy for minors. He also declared Minnesota is a trend Refuge state that will not enforce laws, interfering with children's access to gender affirming care, following from.
